
# **CYPRUS OPENS APPLICATIONS**



FOR THE EU BLUE CARD



#### A STRATEGIC PATHWAY FOR SKILLED PROFESSIONALS

As of Monday, 7th July 2025, Cyprus officially joins the EU Blue Card scheme, opening the door to a new era of professional migration for highly skilled non-EU nationals. This long-anticipated step positions Cyprus as an attractive destination for international talent, aligning with broader European Union goals to strengthen the knowledge economy and promote legal migration channels.

For skilled workers in key industries such as information technology, pharmaceuticals, and maritime sectors, the EU Blue Card represents more than just a work permit — it's a gateway to long-term residence, mobility across Europe, family reunification, and, in some cases, tax advantages.

Below, we break down what the Cyprus EU Blue Card is, who it's for, and why this might be a compelling opportunity for globally mobile professionals and their families.

# WHAT IS THE EU BLUE CARD?

The EU Blue Card is a residence and work permit for highly skilled non-EU nationals, enabling them to live and work in an EU country with specific rights, benefits, and conditions. The scheme was created to attract qualified professionals to the European labour market and offer a competitive alternative to other international destinations such as the UK, Canada, and the U.S.

With the formal rollout in Cyprus, the country now offers eligible applicants the chance to obtain a Blue Card and enjoy the rights that come with it — not only in Cyprus, but across the EU.

#### KEY FEATURES OF THE CYPRUS EU BLUE CARD PROGRAMME

Here's what applicants need to know:

#### Minimum Salary Requirement

Applicants must have a binding job offer or employment contract with a gross annual salary of at least 43,632. This threshold is based on 1.5 times the national average salary and may be updated periodically.

### **Eligible Sectors**

The Cyprus Blue Card is initially being rolled out for professionals in the following strategic industries:

- Information and Communication Technology (ICT)
- Pharmaceutical and medical research
- · Maritime and shipping

These sectors reflect Cyprus's ongoing investment in digital infrastructure, research, and its status as a regional maritime hub.

#### **Academic & Professional Qualifications**

Applicants must provide evidence of:

- A recognised university degree or equivalent professional qualification
- At least five years of relevant experience in their field of employment, if a formal degree is not held

All qualifications must be officially recognised or validated according to Cyprus or EU regulations.

#### BENEFITS OF THE EU BLUE CARD

The Blue Card is designed to offer significant benefits that go beyond the right to work:

## **Intra-EU Mobility**

Blue Card holders can move and work in other EU countries (that are part of the scheme) under simplified conditions after 12 months of residence in Cyprus. This is particularly useful for companies with cross-border operations or professionals seeking regional mobility.

### **Family Reunification**

Spouses and dependent children of Blue Card holders are eligible to join the primary applicant and may receive residence rights for the same duration. Spouses are also granted full access to the local labour market, making it an attractive option for dual-career families.

### Pathway to Long-Term Residence

After five years of continuous legal residence in the EU (with at least two years in Cyprus), Blue Card holders may become eligible to apply for long-term EU residence status, with enhanced rights and greater security.

## APPLICATION PROCESS IN CYPRUS

Applications for the Blue Card can be submitted to the Cyprus Civil Registry and Migration Department, starting 7 July 2025. The process generally includes:

- Employment Contract Submission Must meet salary and duration criteria (minimum 1 year).
- Qualification and Experience Documentation Including university degrees,
  CV, and professional references.
- 3. **Health Insurance** Proof of valid medical coverage in Cyprus.

- Clean Criminal Record From both the applicant's home country and Cyprus (if previously resident).
- 5. Passport Validity A valid passport with at least 12 months' validity.

Application fees and biometric data may also be required. Processing times are expected to vary but may take up to 90 days from submission.
